If you sell Individual products on the federal Marketplace, be sure to secure your 2022 Federally Facilitated Marketplace (FFM) certification ahead of the selling season.

**Click here** to log in and complete the FFM Certification.

Requirements to earn commissions for Marketplace Qualified Health Plans (QHPs):

- Be appointed with the QHP issuer in accordance with state law
- Have completed FFM registration (including required training) for the applicable plan year at the time of enrollment
- Read and sign all applicable Marketplace agreements
- Be licensed with an active health-related line of authority in the state(s) where the QHP is offered through the Marketplace
